	Reply:	Class "C" estimate shall be provided for 2019 budget purposes by October 15, 2018
5	Question:	Provide clarification that this is a utility locate request and not a comprehensive underground utility locate request (i.e. Subsurface Utility Engineering).
	Reply:	All Underground utilities and services must be identified in the topography survey.
6	Question:	Provide clarification that only a minimum of two alternatives/strategies are required
	Reply:	Prepare a minimum of two alternatives
7	Question:	Provide clarification the timing provided in section 2.2 and the target dates listed in 2.12 do not provide time to have a topographical and legal survey completed.
